Classes of Members

A life member is exempted from paying an annual membership fee but shall, subject to rule 4; continue to be a member for the duration of his or her natural life. Life members will not be entitled to vote.

Associate Members - An associate member means an approved individual, a company or a registered / incorporated Association / Organization which has been admitted to the membership of the Bhavan and which is represented by one duly authorized person having NO vote.
